# Navigating the Stratford Town Trust Grant Application Process: Your Guide to Success

Stratford Town Trust is committed to supporting organisations and work that benefit the community. This guide outlines the key steps involved in our grant application process and gives you valuable insights into how we make our funding decisions. We aim to act with integrity, transparency, and be supportive.

## Step 1: Short Expression of Interest (EOI)

- Start here: Before investing time in a full application, submit a concise EOI form. You'll find this on our website. We also encourage you to speak to us. We're happy meet virtually or chat over a cuppa about your work.
- What we assess: Briefly describe your project, its intended beneficiaries, budget needs, and alignment with our funding priorities. The more clarity you provide, the better we can understand your project's potential impact.
- Our feedback: Our grants team carefully reviews all EOIs. If we see a strong fit
  with our priorities and available funding, we'll invite you to proceed with a full
  application. If your project is unlikely to be funded, we'll provide constructive
  feedback at this stage.

## Step 2: Full Application

- If invited to complete an application, answer the questions clearly and concisely, focusing on the five key topics:
  - How well your work meets our grant themes. <u>You can find out more here</u> about 2024's themes and focus.
  - Community and user involvement. We value genuine participation from the community in work that impacts them.
  - Impact on quality of life. This includes understanding how you'll map and track impact.
  - Collaborative and partnership working.
  - Budget and financial position.

### Step 3: Assessment and Decision-Making

• Behind the scenes: Our grants team thoroughly and thoughtfully assesses each full application, scoring against our internal funding criteria. This aligns with the five topics (outlined in section two) covered in your application. We will maintain a two-way relationship with you to explore your application throughout the process.

- More than just scores: While scoring plays a role, we want to ensure a balanced distribution across our funding themes, diverse organisations, and project sizes. This approach promotes inclusivity and maximises community impact.
- Recommendation to Trustees: We wrap all this up into final funding report presented Trustees, who make the final funding decisions.

Timeline: The entire assessment process typically takes 6-8 weeks. We strive to communicate effectively throughout the process.

#### Remember:

- Clarity is key: The clearer and more comprehensive your EOI and full application, the better we can understand your project and its potential contribution.
- If you have videos or case studies that showcase your work and add value, we'd love to see them.
- Alignment matters: Demonstrate a strong alignment with our funding themes and community needs for a stronger chance of success.
- Feedback is valuable: Utilise any feedback we provide at the EOI stage to strengthen your full application.

## Community consultation for grant seekers

Identify your "community."

- New project? Who'll benefit most? Are you empowering young people, tackling loneliness in older people, or reviving that neglected green space? Knowing your target group is key.
- Existing work? Who's already involved? Think about users, volunteers, and anyone impacted by your efforts.

Get the conversation rolling.

- Keep it clear and friendly: No jargon, just chat about your goals and how you're making Stratford a better place.
- Listen up! This isn't a lecture. Hear their feedback on your project or existing work. What do they love? What could be improved?
- Be open-minded: Maybe your project needs a tweak, or your existing work could benefit from a fresh perspective. Embrace suggestions from your community.

Show don't just tell.

- New project? Mock-ups, sketches, or even a prototype can bring your idea to life.
- Existing work? Testimonials, photos, or impact reports showcase your achievements.
- For both: Share success stories! Let real people's voices speak for your project or work.

Bonus tips:

- Think outside the box: Host a workshop, run a survey, or hold a pop-up event. Get creative with how you gather feedback.
- Partner up: Team with other local groups or organisations. Sharing resources and ideas strengthens your application.
